# **December 2021 Newsletter**

Dear Colleague,

During November 2021, 1,703 liquid cargo vessels, or 8,994,8050 DWT were risk rated by IMRRA's analysts. Year-to-date 21,693 Wet Cargo vessels (Gas, Oil, Oil Product tankers and OBO's), were requested to be risk rated.

In November, 28.5%, or 486 Red & Amber warning vessels were risk rated. 58 vessels had five-ormore Port State Control deficiencies, seven vessel detentions (up one vessel from October), were analysed in detail. 26 vessel incidents were recorded and researched.

**November's Highest Red Risk Rated Vessel** is the BLACK FUEL IMO 8407632 Chemical Tanker risk rated at 76%, the highest so far for 2021. The rating vessel's risk rating is 39% over the fleet average of 36%. The BLACK FUEL demonstrates the importance why charterer's undertake a final vessel risk rating before signing on the dotted line.

**November's Top Green Risk Rated Vessel** is the SOMTRANS XXI, Chemical Barge, IMO 02333400 risk rated at 21%, eight-percent lower than the vessel type average of 29%.


The Oil Tanker risk increased by 0.02%, with Chemical Oil Product Tanker and Gas Carriers increasing by 0.01% and 0% respectively.
