



Vessel Risk Reporting Service: New Red Risk Rated Vessel Warning

28/06/22 Collision NEMESIS #IMO8102799 Greek Flagged General Cargo Vessel Built 1983.

Risk Rated Red at 60%, fleet type average 42%.

Second Incident in June 2022, following one grounding and two machinery damage and failures in 2020.

Marinerating.com analyst commentary: The number and nature of the NEMESIS incidents listed below, for example machinery failure, grounding and collisions are signs of a substandard vessel working long beyond its scrapping age.

The vessel is of an older defective design and construction, with inadequate equipment, maintenance and tools. Typically, as proven in this example, vessels of this age are crewed by poorly trained personnel, and not maintained to acceptable safety standards.

Incident: NEMESIS IMO 8102799 contacted passenger vessel Nemesis Ro/Ro

Vessel (IMO: 8102799) came in contact with ro/ro (IMO: 7205219) due to strong winds, Kea, 28 Jun 2022. Ro/ro had dents & abrasions 5-6metres above water line & other vessels guard rails in middle deck was damaged. No injuries/pollution.
